Grading Policies

Students will earn their grades by participating online and completing the assignments listed below. The final scale will generally follow the standard UW 4.0 scale (>95% = 4.0, 85% = 3.0, etc.), but I reserve the right to determine the final grading scale after all points have been earned.

1. Participation

100 points

Participation is extremely important to both your education and the education of your classmates. You will have opportunities to participate in online discussion boards and in our group and full zoom sessions. Please arrive early for each zoom session fully prepared. You should be able to demonstrate your understanding of the relevant issues and problems in the assigned readings and cases. Share your knowledge and help others understand your point of view. Some of the criteria used to judge the effectiveness of your participation include:

- Are you willing to participate?
- Do your comments show evidence of appropriate, insightful analysis of the case?
- Are your comments relevant to the discussion?
- Are you a good listener as well as speaker? Can you play off of the comments of others?
- Are you willing to test new ideas? Or are all of your comments "safe"?
- Do you work well with others during group projects?

As a courtesy to everyone, please do not video, tape, or in any way record any of our discussions, and do not share materials or conversations from this course with anyone outside of the course without the instructor's approval. The inappropriate or impolite use of technology will have a significant negative impact on the participation grade.

2. Quizzes 200 points

The course utilizes Canvas quizzes both to facilitate learning of new material and to test understanding of key principles and ideas. Quizzes include multiple choice and short answer questions and must be completed as instructed on Canvas.

3. Individual Memo

100 points

Each student must write a memo to Silvia Ring, the decision-maker in the Merck Sharp and Dohme Argentina case, encouraging her either to accept candidate #16 or not. Details on how to structure the assignment will be discussed in class and provided with the assignment. Memos must be uploaded to Canvas before the start of the fourth session.

4. Ethical Culture Analysis

100 points

As part of discussion of Managerial Ethics, students will consider a framework for auditing the ethical culture of an organization. Subsequently, the student will select an organization, identify a related set of (un)ethical behaviors within the organization, and conduct an analysis that identifies and assesses the elements of the organization's culture that are related to those behaviors. The student will create a document that details this analysis. Details on how to structure the submission will be provided with the assignment.

5. Group Analyses (2)

50 points each

As part of our discussion on Organizational Ethics, students will consider a framework for assessing organizational activities. Groups will submit an analysis of 1) a CSR activity in an organization of their choice and 2) a social enterprise pitch developed in class. Each analysis will detail the activity/social enterprise they are addressing, develop goals and metrics related to the activity/social enterprise, and conclude with a discussion of how to interpret the data to be gathered (i.e., forecast possible outcomes and how to respond). Other details relevant to this assignment will be available on Canvas.

Late or Missed Assignments
