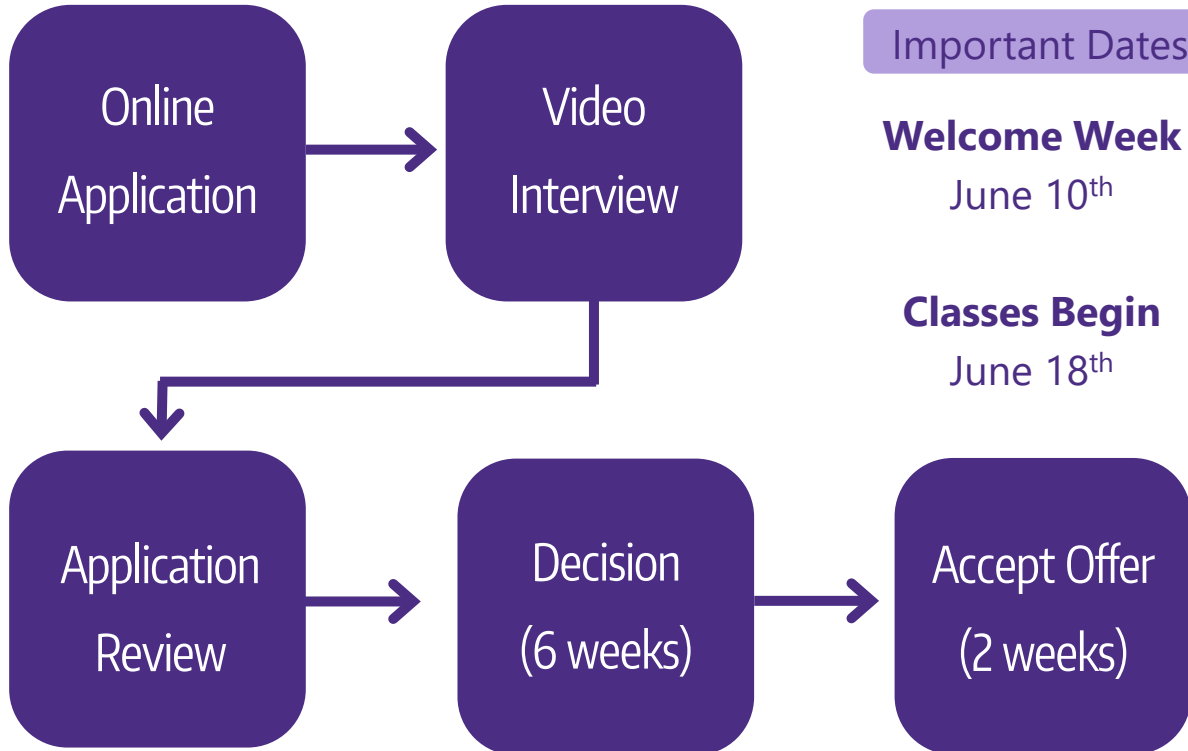

- Official copies sent to UW Graduate School after offer of admission

GPA

Minimum 3.0 GPA in the last 60 semester/90 quarter credits.

- Studies outside of the U.S. will need to be converted to a 4.0 scale, and transcripts must be translated to English.

Two Recommendations

Designate Recommendations

You can designate recommendations before and after you have submitted your online application - **up until the program deadline.**

Two recommendation letters are required. Preferably, recommendations should be provided by professional contacts versus academic or personal contacts. If you do not have professional work experience you may use academic contacts.

Designate your recommenders in your online application profile. Recommenders will receive an email directing them to the online recommendation form which includes a grid to complete as well as a space to upload a PDF of their letter.

Please designate the people you intend to use for your required recommendations. **Business Administration - Foster School of Business - MS in Business Analytics** requires 2 recommendations. **When you designate a recommendation, the person you have designated is immediately sent an email to submit a recommendation on your behalf.** Please do not designate until you are ready to have the recommender contacted.

If, after designating a recommendation, you learn that the recommender will not submit a recommendation, you may remove the recommendation by selecting the "withdraw" link in the action column of the table below. You cannot withdraw a recommendation once the recommender has submitted it. Your recommenders can submit letters of recommendation after you have submitted your online application.

Test Optional: GMAT or GRE

For a candidate to be competitive without a test score, they must demonstrate quantitative and program readiness by meeting *at least two* of the following criteria:

- Strong quantitative or analytical ability demonstrated throughout educational records, with a cumulative GPA at or above 3.3 on a 4.0 scale, and similar grades in quantitative courses.
- An undergraduate, masters, or advanced degree in STEM (i.e., science, technology, engineering, statistics, economics, finance, information systems, mathematics) with strong academic performance
- At least **four** 300-to-600-level (or U.S. equivalent) quantitative or analytical courses.
- Two or more years of progressively responsible professional work experience which clearly demonstrate deep quantitative or analytical aptitude.

These criteria will be considered in holistic review along with other elements of the application in the context of the competitiveness of the overall applicant pool.

Why Take It	The test is required for admission to most graduate schools and a growing number of business schools.	The test is required for admission to most business schools.
Test Structure	The GRE consists of a 60-minute Analytical Writing section - with two essays at 30 minutes each. There are two 30-minute Verbal Reasoning sections. There are two 35-minute Quantitative Reasoning sections. There's also a 30-35 minute experimental section that can be either math or verbal.	The GMAT consists of a 30-minute Analytical Writing section with one essay, a 30-minute Integrated Reasoning section, a 62-minute Quantitative section and a 65-minute Verbal section.
Test Format	Offered as a computer adaptive by section exam. Paper version only offered in areas of the world where computer-delivered testing is not available.	The GMAT is a computer-adaptive test.
How It's Scored	Verbal and Quantitative scores from 130 to 170 in 1-point increments.	The overall, or composite, GMAT score ranges from 200 to 800 in 10-point increments.

English Language Proficiency

If your native language is not English, you are required to demonstrate English language proficiency.

- A bachelor's, master's, or doctoral degree from an accredited US institution.
- A bachelor's, master's, or doctoral degree from accredited institution in a specified country on Memo 8
- Official documentation from undergraduate degree-granting institution verifying that all instruction was in English
- Complete an English Language Proficiency Exam & send official score report

English Language Proficiency

- A bachelor's, master's, or doctoral degree from an accredited US institution.
- A bachelor's, master's, or doctoral degree from accredited institution in an English-Speaking Country
 - Australia, Bahamas, Canada, Ireland, Jamaica, New Zealand, Singapore, Trinidad and Tobago, or United Kingdom

English Language Proficiency
