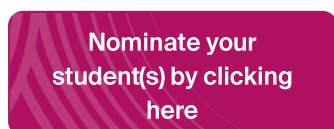
Application procedure

Nomination as an exchange student at Paris School of Business takes place before the above-mentioned dates by the home university.

Nominations are to be sent via our nomination link.

We do not accept nominations via email. Once the student has been officially nominated, they will receive e-mail with an application link. Once the student has completed their application and has been accepted to the program, they will receive mails with further information regarding the acceptance letter, accommodation, modules etc.

Language requirements

All non-native students (regardless their nationality) must satisfy language proficiency and submit an official test in English:

- ◆ IELTS 6.0
- ◆ TOEFL iBT 80
- ◆ Cambridge 170
- ◆ Duolingo 100
- ◆ **We also accept local tests conducted by the partner university; the latter must satisfy a B2 level.**

Please note the issuance of the language proficiency tests or letter **shouldn't be older than 2 years old** at the moment of the application.

For students who have been enrolled in 100% English programs for **at least two years** at their respective home universities, we accept an official letter from the university stating their English level and that they are enrolled in full English programs as proof.

French as a Foreign Language course is available to exchange students as a module only in the Study Abroad track program.

Students studying in French must satisfy a DELF B2 proficiency test or a letter from the language department of their home university attesting their language proficiency.



Academic requirements

Students should have studied for at least one year in a business or economics related with an average grade of 2.3/4 of the GPA system to enroll in our international programs.

Required documents for application

- ◆ Passport copy (attention to the expiry date!)
- ◆ Most recent official transcript of records of the home university
- ◆ Proof of English or French proficiency
- ◆ A passport size coloured photo

Insurance requirements for incoming exchange students

Before arrival, students must purchase a full health cover for the length of their stay.

- ◆ EU citizens do not need to purchase the health cover but must provide a copy of their European Health Insurance Card (EHIC).
- ◆ Non-EU citizens must purchase private insurance covering their whole period of stay in France.
- ◆ Students will have to submit a copy of their International Health Insurance to PSB IO before start of classes

Courses and ECTS

The course selection process begins approximately two months before the beginning of the semester. Make sure the student is aware of the courses they're allowed to take at PSB by consulting our course catalogues below:

- ◆ Fall 2025 English Course Catalogue
- ◆ Fall 2025 French Course Catalogue

Students can take a workload from 6 ECTS and up to 30 ECTS per semester (1 course minimum and up to 5 maxima per semester).

Acceptance on these courses is subject to academic prerequisites, timetabling constraints and number of students enrolled.

The first week of lecture is the “add & drop period” during which any changes must be reported and approved by the Academic Department at PSB. After that, courses cannot be changed or removed and will later appear on the transcript.

Around 20% of the courses will be online, and 80% on campus.

Visa process

All non-EU students coming to Paris School of Business for an exchange program must have a student visa, here is a step by step process:

- 1. Admission:** First, get accepted into a French university or school and receive an official admission letter.
- 2. Campus France (if applicable):** Depending on the country, students may need to apply through [Campus France](#) before applying for a visa. Check their website for country-specific procedures.
- 3. Visa Application:** Students must then apply for a **long-stay student visa (VLS-TS)** at the French consulate or embassy in their country of residence. They'll need documents like:
 - ◆ A valid passport (still valid three months after the end of their intended mobility)
 - ◆ Proof of admission (letter from PSB)
 - ◆ Proof of financial resources (around €615/month)
 - ◆ Proof of accommodation in France
 - ◆ Health insurance (if required)
- 4. Biometric Data & Interview:** Some applicants must attend an in-person appointment to provide fingerprints and answer questions.
- 5. Approval & Arrival:** Once approved, students can travel to France with their visa. Should students stay for longer than a semester, they must validate their visa online on the [official website](#) to get a residence permit.



Accommodation

Paris School of Business does not provide on-campus accommodation and students must look for housing independently.

We send to all accepted students before the start of the semester our **Accommodation Guide**, where students find all the necessary information to find accommodation in Paris, as well as the list of our housing partners.

Approximate cost of living per month

Cost depends on the lifestyle of each student, but we consider between 1200.00 and 1500.00 euros per month to live in Paris.

Orientation Day

Usually held at the beginning of the semester, PSB IO offers an "Orientation Day", where we provide useful information concerning the study program: we will show students Paris School of Business' campus, our extranet and PSB Learn systems and other important things they need to know while studying in France.

Please consider that the orientation is **mandatory** for all international students.

Transcripts

A soft copy of the transcript of records will be sent via e-mail to the home university. This can take around 10 weeks after the final exam period.
